ARTICLES OF INCORPORATION

of

Know All Men By These Presents, that the undersigned incorporators, desiring to organize a corporation, not for profit, under the provisions of Article 19, Chapter 31, Colorado Revised Statutes, 1963, make, sign, and verify these Articles of Incorporation:

ARTICLE I

The name of the Corporation is The Colorado-Wyoming Regional Council of the Mountain Rescue Association.

ARTICLE II

The Corporation is to have perpetual existence.

ARTICLE III

The purposes of the Corporation are:

1. To foster unity among mountain search and rescue organizations and related support groups within the subject region,

2. To promote the concept of a national association of mountain search and rescue groups within the framework of the Mountain Rescue Association, a Washington corporation, not for profit,

3. To increase the regional mountain search and rescue capability through establishing standards of group proficiency, assisting groups desiring to meet these standards, and evaluating the capability of groups applying for membership in the Mountain Rescue Association and this regional council,

4. To strengthen the operational capability of member groups through the creation of a permanent system for coordination and

communication, and

5. To promote safety in mountain recreation.

ARTICLE IV

The business and affairs of the Corporation shall be managed by a Board of Directors which shall exercise all the powers of the Corporation except as otherwise provided by law or by these Articles of Incorporation. There shall be six Directors or such larger or smaller number as shall be fixed by the By-Laws or from time to time by amendment of the By-Laws.

ARTICLE V

The initial Board of Directors shall consist of six members. The names of the persons who are to serve as Directors until their successors are elected and qualified are: David N. Church, Albert G. Lambert, L. David Lewis, David W. Moore, Asa Ramsay, and John Wellington.

ARTICLE VI

The principal office of the Corporation shall be Room 30, University Memorial Center, Boulder, Colorado.

Article VII

The Directors shall have power to make By-Laws and to amend or alter the By-Laws from time to time as they deem proper for the administration and regulation of the affairs of the Corporation.

ARTICLE VIII

The right is reserved from time to time to amend, alter or repeal any provisions of, and to add to, these Articles of Incorporation in any manner now or hereafter prescribed by the laws of Colorado.

ARTICLE IX

Income or property of the Corporation shall not inure, in whole or in part, to the Directors or members of organizations belonging to the Corporation or to any other individual whatsoever. Assets of the Corporation shall be transferred, upon dissolution, to other organizations formed and operated for similar tax exempt purposes or to federal, state or municipal governments.

ARTICLE X

The names of the incorporators are: David N. Church, Albert G. Lambert, L. David Lewis, David W. Moore, Asa Ramsay, and John Wellington.
